PUBLIC NOTICE

In terms of Regulation 22(6) of the Securities and Exchange Board of India (Delisting of Equity shares) Regulations – 2009 (“Regulations”) and as per the rules made under Section 21A of the Securities Contracts (Regulation) Act, 1956 and the Rules, Bye-Laws and Regulations of BSE Limited (“the Exchange”), **NOTICE** is hereby given that 28 companies (given in Table-1), and 28 companies (given in Table-2), are delisted from the platform of the Exchange with effect from March 5, 2018.

The Exchange had issued Public Notice dated June 23 and June 24, 2016, May 6 and 9, 2017, July 7, 2017 and July 15, 2017 in terms of Regulation 22(3) of the Securities and Exchange Board of India (Delisting of Equity shares) Regulations – 2009 (“Regulations”) proposing to delist certain companies, which had been suspended for a period of more than 3 years on account of various clauses of the erstwhile Listing Agreement, from the Exchange. These companies had either failed to reply to the Show Cause Notice/ Supplementary Show Cause Notice issued by the Exchange or failed to take steps for revocation of suspension in the trading of their securities or had consented to go ahead with the compulsory delisting.

The Public Notice had provided 15 working days from the date of the Notice to any person aggrieved by the proposal to delist to submit representation in writing to the Delisting Committee of the Exchange.

The Delisting Committee of the Exchange has, after considering the representations from companies and investors received during the mandated time and the facts in the matter passed Delisting Orders in the case of 36 companies. The list of companies along with addresses as per Exchange records is given below:

Notes:

- The securities of these companies cease to be listed w.e.f. March 5, 2018 and therefore are not available for trading on the platform of the Exchange.
- These companies would be moved to the Dissemination Board of the Exchange for a period of 5 years as directed by SEBI.
- The names of the promoters as available on stock exchange records or received from the concerned ROCs, RTAs or Depositories have been included.
- *These companies are under liquidation and hence:
 - The provisions of SEBI circular no. SEBI/HO/CFD/DCR/CIR/P/2016/81 dated September 7, 2016 do not apply to these companies.
 - **For companies under liquidation the following directions have been received from SEBI in the matter:
 - If a company has been compulsorily delisted before the appointment of provisional liquidator or the order of winding-up, then the restrictions provided under Regulation 24 of Delisting Regulations shall be applicable.
 - If the company has not been compulsorily delisted before the appointment of provisional liquidator or the order of winding-up, the process of delisting will happen by operation of law and the restrictions under Regulation 24 of Delisting Regulations shall not be applicable."
 - # Accordingly, it may be noted that for all companies which are 'Under Liquidation/ Liquidated' and which are compulsorily delisted, the consequences of compulsory delisting as provided for in Regulation 24 of the SEBI Delisting Regulations would not apply to the companies / promoters / whole time directors of these companies as the date of the appointment of provisional liquidator or the order of winding up is prior to the date of compulsory delisting i.e. March 5, 2018.
- As per SEBI Delisting Regulations, 2009 the following consequences of compulsory delisting would apply to the companies not under liquidation /liquidated:
 - In terms of Regulation 24 of Delisting Regulations, the delisted company, its whole-time directors, promoters and group companies shall be debarred from accessing the securities market for a period of 10 years from the date of compulsory delisting.
 - As per SEBI circular no. SEBI/HO/CFD/DCR/CIR/P/2016/81 dated September 7, 2016, till the time promoters of the Company provide an exit option to the public shareholders in terms of value determined by the valuer, the following consequences of compulsory delisting would also apply:
 - Non-transferability of any of equity shares by the Company, by way of sale, pledge, etc., of any of the equity shares.
 - Freezing of equity shares and corporate benefits thereof held by the promoters/ promoter group.
 - The promoters and whole-time directors of the Company shall not be eligible to become directors of any listed company.
 - It may be noted that the onus of giving exit to the public shareholders and informing the stock exchanges about the same is on the promoters of the company. In case exit is not provided by the promoters, appropriate action would be taken against such entities.
